## Repairer Authorisation Form

The VISION parts management system ("VISION") is a sales and management service provided by OEConnection Limited ("OEC") on behalf of Vehicle Manufacturers ("VM(s)") and offered to Bodyshop Repairers ("Repairers ("Repairers").

VISION extracts data ("Repairer Data"), as defined in section 1 below, from the Repairer's vehicle estimating platforms.

This data is merged in OEC's data warehouse with product and pricing information provided by the relevant VM, and the resulting information is then used to provide sales management services and market intelligence for the VM as well as purchasing information for the Repairer.

By signing this Authorisation Form, the Repairer agrees to the use of the VISION service and to the extraction of Repairer Data from their vehicle estimating platforms, subject to the terms and conditions outlined below.

## 1. Data Collection and Management

- 1.1 The Repairer Data remains the property of the Repairer.
- 1.2 The Repairer declares and guarantees that the Repairer Data has been collected in compliance with all laws applicable to the collection and protection of personal data. OEC does not collect or store any data containing personal data.
- 1.3 The Repairer Data will be extracted automatically from the Repairer's vehicle estimating platforms via the VISION service, as defined by OEC.
- 1.4 The Repairer Data collected will be limited to:
  - 1.4.1 Vehicle make, model, VIN number, registration number;
  - 1.4.2 Parts utilised on the repair of the vehicle;
  - 1.4.3 Parts supplier and pricing; and
  - 1.4.4 Mechanical repair operations and pricing.
- 1.5 The Repairer Data will be collected, reported and integrated into the VISION database to provide a detailed analysis of:
  - 1.5.1 All the VM parts utilised on the repair of the vehicle (defined by the VM part numbers); and
  - 1.5.2 All other parts, sourced from aftermarket suppliers utilised on the repair of the vehicle (defined by the aftermarket supplier part numbers).
- 1.6 The Repairer Data will be used by OEC to assist VMs with their parts pricing and marketing strategies.
- 1.7 Information about specific applications for the use of the Repairer Data may be obtained from OEC upon request.

#### 2. Systems Access

By signing this Authorisation Form, the Repairer expressly allows OEC to access their vehicle estimating platform, for the purposes of:

- 2.1 Utilising the VISION service;
- 2.2 Ongoing collection of Repairer Data; and
- 2.3 The export of that data to OEC's data warehouse.

### 3. Obligations to Access and Process Data

OEC expressly agree to:

- 3.1 Manage the VISION service and Repairer data in compliance with the Data Protection Act 2018.
- 3.2 Process Repairer Data with the utmost care to ensure confidentiality and integrity of the Repairer Data, by adopting the necessary technical and organisational measures to prevent alteration, loss, process, or unauthorised access of the Repairer Data.
- 3.3 Not duplicate or reproduce all or part of the information owned by the Repairer, except for cases where it is necessary for the correct operation of the VISION service or is expressly requested by the Repairer.
- 3.4 Keep confidential all personal data in the Repairer Data to which the VM has access, even after the termination of the VM's extraction and data export obligations and after the dissociation of the Repairer Data.
- 3.5 Except as provided in section 4 below, return or destroy the Repairer Data, as well as the media used, to the Repairer after services have terminated.

#### 4. Termination of the VISION Service

- 4.1 The Repairer may terminate the VISION service by giving three (3) months' advance notice, in writing to OEC by registered letter with acknowledgement of receipt.
- 4.2. OEC reserves the right to terminate the VISION service at its absolute discretion, without notice.
- 4.3 Upon termination, either by the Repairer or OEC, OEC will retain the Repairer's data on file for twenty- four (24) months from the date of the last data transaction registered in the DMS, unless an opposition, rectification, or suppression right can be, and is, put forward as to the Repairer Data and unless the Repairer specifically requests OEC to shorten the duration.
- 4.4 The termination of the VISION service will not prejudice the rights of the VM to register and process personal data of Repairers who have given their consent for such registration and processing, as well as the rights to register and process that economic data and other non-personal data to which the Personal Data Protection laws do not apply.

#### 5. Service commencement

Repairer Data extraction will be managed by OEC. OEC will use an application to read the data extracted from the Repairer's vehicle estimating platforms and transfer the Repairer Data to OEC by way of a secure internet connection.
